MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 28/08/2019 at 3:00 PM in the Conference Hall of APMC (MNI) Azadpur which was chaired by the Secretary and Sh. P. K. Kaushik, Secretary F&V Gazipur was also present as an observer. The issues raised during Jan-Sunwai are as under: -

1. Sh. Sandeep Khandelwal, potato traders from M/s Om Shyam Trader, shop no. A-1137 raised the issues as under: -

(i). He informed that some of the traders selling the Cemented & Clay coated Potato in shed No. 14 which is harmful for the human life. He also stated that no action is taken by APMC in his earlier complaint.

Secretary (MNI) asked DS(Enf.) to enquire the matter and take the sample in the presence of the complainant.

Action DS(Enf.)

(ii). He informed that due to the commercial auto there is a traffic jam in the mandi therefore he requested that the entry time of the Commercial auto may please be fixed.

Action: DS(Gate)

(iii). He raised the issue of illegal parking in front of sulabh sochalya near gate no. 5A.

Secretary (MNI) asked DS(Enf.) & DS(Security) to take the necessary action immediately and also order for removal for Rehari in the mandi.

Action: DS(Enf.)/DS(Secy.)

2. Sh. Hasi, Mosambi traders informed that during the no entry time if the empty vehicle gone out of the mandi the traffic police official challan the vehicle.

Secretary (MNI) asked DS (Security) to fix the meeting with the ACP (Traffic).

Action: DS(Security)

3. Sh. Bhajan Singh, member of APMC(MNI) raised the issue of encroachment in front of POMA shed. He also informed that due to this there is a traffic jan at A, B chowk.

Secretary (MNI) asked DS (Security) to visit the site and resolve the problem immediately.

4. Sh. Yogesh Sonkar, of M/s Raj Kishan & Sons, Shop no. D-418 raised the issues as under: -

(i) He raised the issue of encroachment near shop no. D-438 & near transformer.

Action: DS(Enf.)

(ii) He raised the issue of insanitary condition in Kheera shed and from Shop No. D-403 to D-438. He also requested that the contractor of Sanitation may also asked to present in the next meeting of the Jan Sunwai.

Action: DS(Sanitation)

5. Sh. Deepak Sapra, Mosambi trader raised the issue as under: -

(i). He requested for installation of traffic sign board in the mandi.

Secretary (MNI) asked EE(C) for installation of sign board in the mandi.

Action: EE(C)

(ii). He requested for car parking at service lane of NFM & also requested for deployment of two Security guard in the parking.

Action: DS(Security)

(iii). He informed that APMC calculate the market fee on the basis of model rate but mosambi comes in 7 grade.

Action: DS(MIS)

6. Sh. Prem from shop no A-1019 requested for repairing of roof in shed no. 16 at phar no. 48.

Action: EE(C)

At the end, it was assured in the meeting that steps would be taken to address the grievances and problems of the Mandi stake holders at the earliest.
