MINUTES OF JANSUNWAI

As scheduled a meeting of Jansunwai was held on 08.06.2017 at 03:00 PM in the auditorium of APMC Azadpur Delhi under the chairmanship of the Secretary APMC (MNI) Azadpur.

Following issues were raised during the Jansunwai.

1. Sh. Deena Nath Commission agent informed as under:-

(i) Sewer of A,B,C, & D Block are Completely choked. In rainy reason water over flow on the road and there is sledge every where.

Action: EE(C)

(ii) There is encroachment every where either in street or on road at NSM/NFM. Azadpur. The encroaches spread garbage on road.

Action: DS(S) & DS(Enf)

(iii) The Masakhor must be re-located so that roads be encroachment free and Mashakhor can be rehabilitated somewhere else so that they can earn their livelihood with dignity.

Action: DS (Enf)/Security/E&M

(iv) There is very poor condition of electricity/street light on the road of NSM Azadpur.

Action: EE(E)

2. Sh. Bijender Jain, Nimbu Commission agent raised the issue of allotment of Phar in Nimbu Trade. He is informed that he has more then 10 Lakh Market Fees, but he could not be given Phar in Nimbu.

It was informed by secretary MNI that space should be allotted on rational basis and process of allotment of space will be done in due course.

Action: DS(E&M)

3. Sh. Umesh Kumar, Potato Commission Agent suggest the following points:-

(i) APMC Should conduct Phar allotment in all trade of APMC Azadpur. He also suggested that to easy the pressure on APMC Azadpur Tikri Kham Pur be developed on priority Basis.

Secretary (MNI) also asked to write a letter to area ACP/SHO regarding the worsening of law & order condition in APMC Azadpur.

Action: DS(S)
