Minutes of Jan-Sunwai

Sh. Yogesh Shonker Commission Agent raised the following issues:-


- (i) Sewer in D- Block is completely choked & during raining seasons it over flows. (Action:-EE (C))
- (ii) Floor of D- Block roads are in depleted condition & needs immediate action for repair. The conditions of by lanes so are worse that even cleaning of lanes can-not be performed by machines. (Action:-EE (C))
- (iii) Condition of sanitation needs improvement in all sheds water & residue of fruits are rotting & sticking. (Action:-EE (C))
- (iv) Sewer overflows near N.S.M Gate No. 1, where gate pass are issued. (Action:-EE (C))
- (v) Allotment of Green Vegetable has not been made, it is pending since long. (Action:- E & M)

Sh. Virender Rana, Commission Agent of Potato Commodity, Shop No. A-343 has requested that more space be give to Potato traders & demanded phars as under:-

In Shed No:- 16 Addition phar be provided.

In Shed No:- 16 : 15 Phar be provided.

Sewer of A-Block NSM Azadpur also choked steps to be taken to clear them repair them.  (Action:-EE (C))


Apple traders Association be asked to provide the details of their current sitting position & last financial year's also.
