Minutes of Jan Sunwai

In pursuance of e-mail received from Dy. Director (AM), Directorate of Agricultural Marketing, Govt, of NCT of Delhi, a meeting of Jan Sunwai was held on 16.02.2016 at 12.30 P.M. in the Office Complex in APMC (MNI), Azadpur which was chaired by the Secretary, APMC(MNI). Market functionaries in large were present during the Jan- Sunwai and following issues were raised:-

Sh. Yogesh Sonkar, Commission Agent suggested the following:-

1. Gate near Tomato shed be opened . Secretary (MNI) requested to DS (Gate) place Agenda before Marketing Committee for decision in the matter.
(Action:- DS (Gate))
2. Civil Defence Volunteers deployed in the APMC Azadpur should be directed to perform their duties more efficiently & diligently. They must stop Riksha, Rehri from entering in various gates of Mandi .
(Action:- DS (Security))
3. As the Govt of NCT of Delhi is discouraging the practice of filing of Affidavits for different types of undertaking for official uses. Why did the Commission Agents are being asked to file affidavit for allotment of commodity in APMC Azadpur.
Secretary (MNI) clarified that the under taking given on plain paper on (A-4 size) is sufficient , provided it is signed by the Legal owner of the firm and properly stamped.
(Action:- DS (E&M))
4. It was suggested that power be delegated to Secretary (MNI) for issuing new licence/ change of constitution rather than the Marketing Committee.
5. Feature films should be shown other places of mandi like Parks , A-B Chowk etc.than Auditorium.
Secy. (MNI) informed that due to cold weather Films are shown in the Auditorium. During Summer seasons it will be shown in open at different places of Mandi as suggested by the participants of the Jan-Sunwai.
6. D-Block internal road needs carpeting urgently because condition of the internal roads of the block is so poor that sweeping can not be carried out smoothly.
(Action:- EE. Civil)
7. Lighting installed in the D Block needs immediate repairing.
(Action:- EE.Electric)

11. In all high mast light, bulbs be replaced with LED bulbs, it will not only save electricity but reduce expenditure on electricity also. **(Action:- EE. Electric)**
12. Fan in shed No 14 (part No-2) on middle poles each side be installed, it will have good effect on the stored potato. **(Action:- EE. Electric)**
13. In dispensary ECG machine be installed.
14. Minutes of Jan - Sunwai be uploaded on website of the department.
15. Prop of the Firm M/s Kishan Lal Narender Kr. Co. Shop no. D-405 informed that he has not been allotted phar in Mutter segment despite working in the mandi for the last 10 years.
16. Sh. Vinay Dua of C-68 requested that big Vehicles 18-22 tyres are creating traffic jam in POMA Shed and stops traffic .
