## Minutes of Jan-Sunwai

In pursuance of Circular No. APMC/CO-ORD/Jan.Sun/2015/1729 dated 08.08.2016 a meeting of Jan-Sunwai chaired by Secretary MNI, in pursuance of Sh. R. N. Mangla, Secy, DAMB as observer was held on 16.08.2016 at 03:00 PM at Conference hall of APMC Azadpur. Market functionaries were present during Jan-Sunwai.

While starting the Jan-Sunwai, Secretary (MNI) welcomed all the participants.

 Smt. Sumitra Devi & Sh. Hari Ram, (Ph:- 9069381851) on behalf of Pural/ Grass seller, requested that the said material is used in packing of a number of fruit commodity in NFM/NSM, should be allowed in Mandi as the same is their livelihood & they are facing verymuch financial hardship.

Secy. (MNI) informed that pural is a fire catching material & it spreads garbage in the Mandi. Hence the same can not be allowed to sell in the Mandi: - However Secy. (MNI) offered them an alternate place to sell pural at exit road in NSM Azadpur or outside NFM parallel to Shed No. 18.

- 2. Sh. Awadh Narain, Labour Union Leader raised several problems of APMC Azadpur as under:
  - i) There is a law & order problem in Mandi & the Local Police does not take any action against criminals.

Secy. (MNI) informed that a meeting with concerned SHO will be organized soon to discuss the law & order problems and to take appropriate steps in the Market yards.

- ii) Electric fans are not functioning in Shed No. 5,6,7, & 18. (Action:- EE (E)
- iii) Electric bulbs are not functioning in Shed No. 5,6,9, & 10. needs urgent attention.
- iv) All Dalla lights are not functioning except at Shed No. 14. (Action:- EE (E)

Secretary (MNI) formed a team of Sh. Hans Raj, D.S, Sh. Ramesh Pal, A.S-I & Sh. J.P. Singh, EE (E.) to make survey of all sheds in NFM Azadpur & submit a report immediately. (Action by concerned officers)

- v) There is dump of garbage near Shed No. 18 which has not been cleaned for the last 10 days. (Action:- EE (C)
- vi) To check the Dengue & Malaria fogging be made on regular basis. (Action:- EE (C)

- vii) Challans/action be taken against the traders who are spreading garbage in Mandi.

- 3. Sh. Hari Parsad, Labour contractor informed that there are some old women, who are selling stolen fruits in shed no. 12, action be taken against them. (Action:-D.S. Enforcement)
- 4. Sh. Kanwar Pal, leader of New Fruit Kamgar Union raised the issue of wrong gate passes being issued from the gate office.
  - Sh. Babu Lal, D.S.(Gates) informed that there may be some discrepancy in the gate pass since correct information regarding the consignee and the consignment is not provided to gate staff. He further informed that a standard format has been divested to be field by the commission agent so that there is no error in the gate pass. (Action:- D.S. (Gates)
- Sh. Ravinder Singh, Commission Agent informed that the Vehicles of Green Co-Coconut create jam in front of shed no. 16, remedial action be taken against them.

(Action:-DS. Security)

6. Sh. O.P. Ahuja, Commission Agent, (Mob.No-9711197011) also raised the issue of wrong gate pass. He also informed that in previous Jan Sunwai meeting issue of installation of Wash basin near shed no 10 raised but no action has been taken till date. (Action:- EE (C))

Secy. (MNI) asked the concerned person to take the action for installation of wash basin near shed no. 10. (Action:- EE(C))

- 7. Sh. Umesh Kumar, Potato Commission agaent raised following issue:
  - i) Over Charging by STD booth operators, they are charging more than the MRP. Enforcement Branch should take action against them. (Action:- DS.Enf.)
  - ii) Police verification be conducted for the shop which is given on rent for taking license. (Action:- Ds. Lic.)
  - iii) Licence must inform to APMC in case their rent agreement is cancelled.
  - iv) On all gates, Gate number must be written on big screen board. (Action:- EE (E))
  - v) LED bulbs be installed in all shed except shed no. 14. (Action:- EE (E))
  - vi) Un-authorised construction is taking-place in all the allotted DDA shops/ to commission agents.

Secy. (MNI) asked to concerned branch to take action against the person, who are violation Rules of APMC Azadpur.

- Vii) Minutes of marketing committee be also made available on line. Hence, be uploaded as in case of Jan Sunwai it has been done. (Action:- Ds. (IT))
- Sh. Ravinder Pal Singh, Commission Agent appreciated the efforts of Secy. (MNI) for providing online details of market fees to the all commission agents.
