
1. Sh. Yogesh Sonkar, Commission Agent raised following issues.
  - (i) There is no road lights/ very poor lighting condition in B&D Block & even lights are not there in front of Gate pass office.  
(Action EE (E))
  - (ii) Although new lights have been installed at poles in D-Block, but that are in service road instead of main roads.  
(Action EE (E))
  - (iii) It was recalled that the bulbs of road lights were to be replaced with LED bulbs, but the said task has not been done in-spite of reminders time and again.

  - (iv) There is no road light on exit gate at New Subzi Mandi Azadpur.  
(Action by EE (E))
  - (v) There is also the high mast lights are not functional at exit road.

2. Sh. Umesh Kumar, Commission agent raised in following issue.
  - (i) That there is no U.P.S. installed in APMC office with computer systems be provided in all Branches. Secretary (MNI) asked EE (E) to start the process for installation of UPS, floor wise so that there is no problem in computer systems provided at various branches.
