Minutes of Jan Sunwai

In pursuance of letter no. F8(05)/2015/DAM/MR/3151-3157 dated 14.12.2015 received from Dy. Director (AM), Directorate of Agricultural Marketing, Govt, of NCT of Delhi, a meeting of Jan Sunwai was held on 18.12.15 at 3.00 P.M. in the office complex in APMC (MNI), Azadpur which was chaired by the Secretary, APMC(MNI). SMS were sent on mobiles phone for Jan-Sunwai. Market functionaries were present in large number during the Jan-Sunwai and following issues were raised:-

At the outset of Jan-Sunwai, Secy (MNI) welcomed all participants in Jan Sunwai & requested all of them to raise the issue of common concern.

1. Sh. Ashok Kumar from shop B-181 raised the matter of issuing of wrong Gate pass that causes problem to Licencee at the time of assessment. **(Action:- DS Gate)**
2. Sh. Uma Shankar of Gajjar trade brought to the notice that there is a stagnant water of deep knee height near Gajjar shed and smell badly moreover sewer that area are chocked. **(Action:- EE, Civil)**
3. Secretary (MNI) informed all that:-
 - (i) Mandi is for sale of Vegetables(Gobhi) not for its waste residues(leaves), Secretary(MNI) proposes that a meeting of Gobhi trader will be held shortly in APMC azadpur. **(Action:- DS. E&M)**
 - (ii) As per NGT order, burning of leaves, garbage at any place (inside market) is illegal as it causes pollution in the environment , Hence violators will be challaned.
 - (iii) Recently in Bhatinda District of Punjab, eight labours of Ginger were arrested as they were washing adrak in acid. Hence if any trader or labour indulging in such practice, they must refrain from it.
 - (iv) New sanitation contract will be awarded in Mandi , which will be based on cleaning of the area by the agency and not on manpower. Agency will be paid in proportion to the area cleaned after certification from the authority. However, associations of different trades have to co-operate by providing vacant space to the cleaning agency.

4. Sh. Raju Kholi, adrak trader reminded following issues, which were raised by him in earlier meeting of Jan Sunwai
- (i) No urinal pot was installed in urinal block of Shed no. 3 .
 - (ii) New dispensary be set up in NSM Azadpur on the pattern of NFM.
 - (iii) Raw Chollia's gate passes be issued from gate no. 5.
 - (iv) Allotment be made in Gajjar shed on priority.
 - (v) Juvenile crime be stopped in mandi.
 - (vi) Requested to reduce the challan amount from Rs. 5000/- issued by enforcement branch.
- 6 Secretary (MNI) proposed that
- i) A meeting with local police and WCD department will be conducted shortly to control the juvenile crime in the mandi . **(Action:- DS. Security)**
 - ii) Allotment in Gajjar shed will completed shortly as all preparations have been completed. **(Action:- DS E&M)**
 - iii) On the request of opening of new dispensary in NSM Azadpur ,Secretary (MNI) informed that presently APMC Azadpur has only one doctor, his services can be utilized on alternate day bases in NFM and NSM if required .
- 7 Sh. Rahees Ahmad raised the issue of assessment. He informed that assessment prior to 2012-13, were also carried on, despite instructions issued by the higher authority. Sh. N.P.Rai, D.S Informed that generally assessment from 2012-13 to 2014-15 are carried out and on the request of licensee or due to some other reason assessment of previous period is also carried out. **(Action:- DS. ADC)**
- 8 Secretary (MNI) informed all licensee that market fees be deposited on regular basis, if any trader has not deposited due market fees within 15 days from transaction he will be penalized and interest will also be charged from him and entry of goods of the firm may also be stopped. **(Action:- DS. ADC)**
- 9 Sh. Shyam palledar made a request that palledar wages have not been revised since long. Secretary (MNI) proposed that a meeting of palledar and trader will be conducted in APMC Azadpur and action will be taken accordingly. **(Action:- DS. E&M)**



- ii. Presently there are 24 urinals blocks in the Mandi, it should be doubled as it is essential need. **(Action:- EE. Civil)**
- iii. In A & B block encroachment has increased again, action will be taken as was done earlier. **(Action:- DS. Enf.)**
