
MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 19.03.2018 at 03:00 PM in the conference hall of APMC (MNI) Azadpur which was chaired by Chairman(MNI) and Sh. Udaiveer, Dy.Secretary(DAMB) was also present as an observer. The issues raised during Jan-Sunwai are as under: -

1. Md. Rasheed, Shop No.146, M/s. Chand Sitara Fruit & Vegetable Co. from Okhla (Sub-yard) requested for allotment of auction space in old flower market (Okhla).
Action: DS(Okhla)
2. Sh. Umesh Kumar, Potato commission agent from shop no. A-246 raised the following points:-
 - (i) In the office complex three lifts are installed and none of the is in working condition as several aged commission agents are visiting the APMC office for assessment & are facing difficulties.
Action: EE(E)
 - (ii) There is no departmental canteen in the market-yard of APMC (MNI) Azadpur and this should be made available.
Chairman (MNI) informed that APMC (MNI) is taking action for opening the canteen in the yard of Azadpur Mandi.
Action: DS(E&M)
 - (iii) Licence fee of the covered/ uncovered space has not been revised since long & it needs to be revised.
Action: DS(E&M)
 - (iv) In the office of APMC Azadpur, no UPS has been installed along with the computers, in case of electricity fluctuation computer system can be damaged. Hence UPS system should be installed.
Action: EE(E)
 - (v) Covering shed be built at the Gate No.5 so that during the raining season & summer season, deployed officials in Mandi do not suffer for the extremes of weather.
Action: EE(Civil)
3. Sh. Yogesh Shonker, Commission Agent made following submission: -
 - (i) There is lighting problem on the Sangam shed in NSM Azadpur. More over electric fans also need to made functional as early as possible.
Action: EE(E)
 - (ii) Sewer lines are chowked in A & D Block of NSM Azadpur & need immediate remedial action.
EE (Civil) informed that tender for awarding the work of New sewer system in A & D Block is under process.
Action: EE(Civil)

4. Sh. Rahees Ahmad, Shop No. A-296, raised the issue of space allotment in South Mango.
Dy.Secretary(E&M) asked to the complainant to give the request in writing and action will be taken to resolve his problem.
Action: DS(E&M)
5. Sh. Dara Singh, raised the issue for transferring STD Booth in his name, earlier STD was allotted in his father name.
Chairman (MNI) informed that APMC has taken action as per norm.
Action: DS(E&M)
6. Sh. Akil Ahmed, Commission agent Shop No. A-348 requested for auction space in mutter shed.
Chairman (MNI) asked to Concerned Branch to examine the matter.
Action: DS(E&M)
7. Sh. Krishan Kumar, Commission Agent of Pineapple raised the issue that the rate of the Pineapple of Raja & Rani in APMC record are same but the rates are very differ in both the quality.
Dy.Secretary(Gates) informed that from 1st February 2018 the rates of the Raja & Rani of Pineapple are used to take differently.
Action: DS(Gate)
8. Sh. Harkrishan, Shop No.C-119 raised the issue of language of Assessment Notice.
Chairman (MNI) informed that notices have been issued, as notified in the APMC, ACT 1998.
9. Sh. Mahesh Saini, Shop No. A-268, raised the issue renewal of licence of 131 licence, as no arrival was recorded on the licence in the year 2016-17.
Action: DS(LIC)
10. The proprietor of M/s. Abbas & Sons., Shop No. A-1127 requested for auction space in Lemon trade.
DS(E&M) informed that the auction space of Lemon trade is under construction & when the construction is completed fresh allotment of Lemon trade will take place.
Action: DS(E&M)

Chairman(MNI) requested all participant traders to ensure that no encroachment takes place in mandi so that proper cleanliness is maintained & problem of traffic Jam do not take place. He also informed to all Mandi stake holders that Market Yard of APMC(MNI) Azadpur will remain closed on every Sunday for all commodities w.e.f. 01-04-2018. No gate pass will be issued after 02:00 AM night to 04:59 PM Sunday.
