Minutes of Jan Sunwai

In pursuance of letter no. F8(05)/2015/DAM/MR/2410-22 dated 13.10.2015 received from Dy. Director (AM), Directorate of Agricultural Marketing, Govt, of NCT of Delhi, a meeting of Jan Sunwai was held on 19.10.2015 at 2.00 P.M. in the office complex in APMC (MNI), Azadpur which was chaired by the Secretary, APMC(MNI). Market functionaries in large were present during the Jan- Sunwai and following issues were raised:-

1. Sh. Vijay Kumar Saini, Commission Agent of Khira raised the issue of allotment of space to Khira trade. He informed that despite depositing of market fee up to Rs. 8 Lakh annually, he has not been allotted the space in the Market -Yard.

2. (i) Sh. Yogesh Sonkar of Shop No- D-418 requested that the meeting of Jan Sunwai be conducted on the day of Wednesday, Thursday, Friday as on these days market actively as lesser than the remaining days of the week.

Secy. (MNI) informed the participants that the schedule of Jan-Sunwai comes from the Directorate of Agriculture Marketing and not by the APMC Azadpur. However, their suggestion will be conveyed to Directorate.

(ii) Sh. Sonker again raised the issue of opening Gate at Bharola Road near Tomato Shed. Secy. (MNI) informed that issue of opening Gate at Bharola Road near Tomato Shed will be decided by the Marketing Committee.

(iii) Sh. Sonker also proposed that in the ABCD Block of NSM, Canteen be opened so that all stake holders can be benefited from this.

3. Sh. Vijay Singh of Shop No.-D-1274 raised his issue of Challan of Rs. 10-15 thousand, issued by APMC authorities.

Secy. (MNI) requested the participants that personal issue not to be raised in Jan-Sunwai and application of the grievance be submitted to APMC authorities.

4. Sh. Virender Rana, Commission Agent Potato Shop No.D-434 requested for more space for Potato trade as in the peak season number of vehicles increases.

5. Sh. Raju Kohli, Ginger Commission Agent proposed that a dispensary be also opened in New Sabzi Mandi like already running in NFM.

Secy. (MNI) informed that there is a proposal for opening of New Dispensary in the Mandi.

6. Sh. Sanjay Palledar requested that there should be some welfare scheme in respect of the Palledar working in the Mandi.

Secy. (MNI) informed that DAMB has started a scheme of "Delhi Kisan Evam Market Yard Majdoor Jivan Suraksha Yojana 2015" under which a financial assistance from Rs. 75000/- to Rs. 3, 000, 00/- can be given to the Victim under different categories.




