Minutes of Jan Sunwai

In pursuance of e-mail dated 18.01.2016 received from Dy. Director (AM), Directorate of Agricultural Marketing, Govt, of NCT of Delhi, a meeting of Jan Sunwai was held on 20.01.2016 at 2.30 P.M. in the office complex in APMC (MNI), Azadpur which was chaired by the Secretary, APMC(MNI), Sh Pawan Sharma MLA, Sh Rambaran & Sh. Jafar Alam member DAMB were also present, SMS were sent on mobiles phone for Jan-Sunwai. Market functionaries were present in large number during the Jan-Sunwai.


1. Sh. Naveen Kumar Kashyap, Secretary Delhi Service Legal Authority has delivered a lecture on the free legal aid to the poor, downtrodden & weaker section of the society. He also informed that any needy person can approach to him in Room No. 404, 4th floor Rohini Court Delhi for free legal aid.
2. One Palledar has raised the issue of insufficient payments to the workers in the APMC Azadpur by the commission agent. In this regard Sh. Rambaran, member DAMB clarified the point of payment to the Labourer by the commission agent by giving an example, which is much more than the prescribed amount in the APMC ACT to the Palledars.
3. Sh. Shyam Sunder, a farmer from H.P., has raised the issue of non payment by the commission agent after selling his commodities in Azadpur Mandi. In this regard the respected Secy. (MNI) advised him to submit an application of his grievances in the office of Secretary APMC Azadpur & his case will be settled by the Dispute-Sub-Committee non priority basis.
4. Hon'ble MLA Sh. Pawan Sharma asked to the present gathering not to give any sort of money to any individual or association to get their work done, it will be helpful in creating APMC Azadpur corruption free.
5. Sh. Umesh Kumar a Potato Commission Agent raised the following issues relating to the APMC Azadpur:-
 - i. Market fee should not be increased from 1% to 1.5%.
 - ii. 15 Cemented benches each, be provided in the two parks of the NFM so that people can sit & relax in the park.

- iii. No new Dispensary has been opened in APMC Azadpur as this particular issue has been raised several times in the meetings of previous Jan-Sunwai.
 - iv. No new I-card has been issued until it has been verified by the concerned trade association.
6. Sh. Kashmiri Lal an Apple Commission Agent raised the matter of issuing of wrong gate pass by DEO sitting on gate. He also informed that person issuing gate pass are not paying attention on the contents of the Bilties etc, hence wrong gate pass are issued.
(Action:- DS(GATE))
7. Sh. Beera Singh, commission agent has requested that the newly constructed Gajjar shed in D-Block be allotted to the old occupants of the shed, as they are facing acute shortage of space. DS(E&M) informed that process for allotment has been started, messages has been sent to the concerned commission agents.
(Action:- DS (E&M))
8. Sh. Raj Kumar jain proposed that new exit gate be opened in the N.S.M. Azadpur he further stated that cleaning In Sangam shed is not made on regular basis, presently it is cleaned on weekly basis. In this regard the Secy (MNI) assured that Sangam Shed will be cleaned on daily basis subject to the availability of the vacant space.

9. Sh. Baleshwar has raised the issue of I-cards. In this regard Secy (MNI) informed that a separate meeting of the concerned persons will be held to settle the issue of I-card to be issue to the labourers working in the market yard.
(Action:- DS (E&M))

Sh. R.N. Mangla, Secy (DAMB) was present in the Jan-Sunwai as observer. Meeting ended with vote of thanks to all participants of the market functionaries.
