Minutes of Jan Sunwai

In pursuance of letter No. F.8(05)/2015/DAM/MR/444 dated 12.06.2015 received from Marketing Officer, Directorate of Agricultural marketing, Govt. of NCT of Delhi, a Jan-Sunwai was chaired by the Secretary, APMC (MNI) Azadpur on 22.06.2015 in the presence of the Secretary, DAMB as an observer at the Auditorium of Office Complex in APMC (MNI) Azadpur. Several market functionaries were present at the time of Jan-Sunwai and following issues were raised:-

1. A reference regarding Shed No. 14 was raised by Sh. Meetha Ram, Apple trader for making Status quo as was used in last several years. One of the traders raised the problem of space for stone fruits.
2. One of the trader namely Sh. Virender Rana raised the issue of Potato trader for not shifting from the Shed No. 14.
3. Sh. Amar Jeet Singh (Litti), Maushmi trader raised the issue of cleanliness as in C-Block, has informed that trader of Banana, Papaya Water Mellon etc. through the rotten fruits on road spread garbage and requested to provide the dustbin.
4. Sh. Arun Kumar, Onion trader suggested that allotment of space should be on the basis of arrival of commodities and not on the basis of market fees.
5. Problem of water logging, choking of sewer lines were reported in all the blocks of New Subzi Mandi.
6. Sh. Avadh Narain, of Labour Union informed that sufficient lighting arrangement was not available in the night in Sheds.
7. Sh. Meetha Ram raised the issue of Assessment Notices issued for the year 2002-03. As the traders do not have old records. He also informed that difference in market fees is due to difference of rates of traders and APMC Modal rates.
8. Issue of development of Tikri Kahmpur was also raised so that in future it will be helpful in decongestion of APMC Azadpur.
