### Minutes of Jan Sunwai

In pursuance of letter No. F.8(05)/2015/DAM/MR/806-817 dated 16.07.2015 received from Dy. Director(AM), Directorate of Agricultural Marketing, Govt. of NCT of Delhi, a Jan-Sunwai was chaired by the Secretary, APMC (MNI) Azadpur on 22.07.2015 in the presence of Dy. Director(AM), DAM as an observer at the Auditorium of Office Complex in APMC (MNI) Azadpur. Several market functionaries were present at the time of Jan-Sunwai and following issues were raised:-

1. Sh. Thakur Dass, Commission Agent raised the issue of shifting of Pear (Nashpati) from Shed No. 15. The Secretary informed to the trader that APMC has to look after trade of all the commodities and for the convenience this actions are taken. Every trade will be provided space as per requirement in the Market Yard.
2. Sh. Mahabir Singh, Allottee of shops at Mangol Puri Market, raised the issue for starting of Mangol Puri Mandi. The Secretary (MNI) directed Incharge of Mangol Puri to fix a meeting with the allottees of shops in Mangol Puri in the next week.
3. Sh. Ram Baran, Sri Ram Trading Co. raised the following issues:-
  - (i) Proceeds of previous Jansunwai Minutes be discussed.
  - (ii) Videography of the Jan Sunwai has to conducted.
  - (iii) Work relating to allotment of Space, Assessment, Issue of licence should not be in the preview of APMC and be given to office bare of APMC.
  - (iv) All Electric Bulbs be replaced with LED lights, it will reduce the expenditure on electricity.
  - (v) Empty plastic crates in tomato sheds be not allowed to avoid fire incident in future as happened in Keshopur Mandi.
  - (vi) Out Gate near tomato shed be made functional, which is at present closed to ease the traffic move.
  - (vii) On all Dhalao, Toilets be built on the first floor.

- (viii) On Gate No. 5 and 5A, water Piao be constructed to provide drinking water.
- (ix) If there is proposal to construct Shed No. 19, underground parking provision be considered and on the roof of Shed, residential accommodation be provided to Kisaan.
- (x) Every grievance in Jan Sunwai be numbered and its reply be given to the concerned person.
- (xi) Vegetables/Fruits rate Display Board be erected in APMC Azadpur to give the information to general public.
- (xii) 500 night vision camera be installed in the whole of APMC Azadpur.
- (xiii) Choudhary Hira Singh Park should be cleaned regularly.
- (xiv) Hand Machine be provided at all gates to issue gate pass as is being done by the Delhi Police for issuing Challans.
- (xv) Issue of Transport Centre be settled on priority basis.

It has also been informed by the Secretary (MNI) that on several issues APMC has already taken action such as construction of Piao on Gate No. 5 and fire safety measure in Tomato Shed.

4. Sh. Siya Ram gave a proposal to set up Bank in Kisaan Bhawan.
5. It was suggested in the meeting that five security personal be provided at Gate No. 5 for the smooth flow of traffic and better law and order position. DS Security to look into the matter.
6. Sh. Santosh Kumar, raised the issue of name of POMA Shed. It was also requested to provide water connection at the toilet on Gate No. 5A.
7. Dinesh Kumar, raised the issue of cleanness in the Mandi and stagnation of water near Shed No.14. EE(C) has been directed to look into the problem.
8. Amar Jeet Singh (Litti), Maushmi trader requested to provided Light and Fan in Shed No. 16. EE(E) has been directed to look into the issue.
