Minutes of Jan-Sunwai

Jan-Sunwai was held at 2:30 PM on 23.10.2017 in the conference hall of APMC (MNI) Azadpur which was chaired by Secretary (MNI). The issues raised during Jan-sunwai are as under: -

1. Secretary (MNI) informed to the traders that garbage of Azadpur Mandi has been refused by MCD to take at the MCD dumping yards. The temporary arrangement was made by the APMC at Tikri Khampur post, but the villagers of Tikri Khampur & neighbour villages started protest against the entry of the vehicle loaded with garbage of Azadpur Mandi. Villagers have pitched tents out side the gate of Tikri Khampur post, so that no truck loaded with garbage be allowed to enter in the Tikri Khampur post.

He requested to all that necessary steps be taken to stop the entry of grass loaded vehicle. He also requests that traders to minimise to use packing material in the commodity such as mosambi, orange, green coconut & green vegetable etc. so that garbage generation be reduced. He also suggested that traders may reload the remaining packing material into vehicle while return from mandi.

- 2. Sh.Umesh Kumar potato commission agent raised the following issues as under:-
 - (a) He informed that in entire shed No. 14 electricity LED bulbs are not in working conditions & even after lapse of one month period.
