Minutes of Jan Sunwai

In pursuance of letter no. F8(05)/2015/DAM/MR/2761 dated 16.11.2015 received from Dy. Director (AM), Directorate of Agricultural Marketing, Govt, of NCT of Delhi, a meeting of Jan Sunwai was held on 23.11.2015 at 3.00 P.M. in the office complex in APMC (MNI), Azadpur which was chaired by the Secretary, APMC(MNI). Market functionaries in large number were present during the Jan- Sunwai and following issues were raised:-

1. Sh. Umesh Kumar, Potato commission agent raised some issues:-

i) The date of Jan- Sunwai be informed in advance & it should be decided that on specific date Jan-Sunwai will be held.

Secy. (MNI) informed that date of Jan-Sunwai is fixed centrally in last week by the Directorate of Agricultural Marketing.

ii) The Date of Jan-Sunwai be given wide publicity and informed to the Commission Agent through various means of communication such as e-mail, message, notice on board of different location, announcement through mike and through Electronic Display Board , on which rates are displayed regularly.

iii) He also informed that at out gate high mask light is not functioning at all & some alternative arrangement be made on priority basis. **(Action:- EE(E))**

2. Sh. Siya Ram trader suggested that new toilets be built in mandi as there are ques in the morning in the existing toilets. **(Action:- EE(C))**

3. Sh. Virender Rana potato agent made a request that a 6x6 feet cabin be built in potato shed for each agent so that commission agent can work on their computer from these cabins. He also suggested that level of Poma Road be increased and shed be constructed one way. **(Action:- EE(C))**

In the last Secretary (MNI) informed to all participant that Delhi Govt. is organizing a Special Sanitation drive w.e.f. 22/11/2015 to 30/11/2015. All stake holder of Mandi are requested to give their best in keeping Mandi neat & clean.
