

Minutes of Jan Sunwai

In pursuance of letter no. F8(05)/2015/DAM/MR/ dated 20/08/2015 received from Dy. Director(AM), Directorate of Agricultural Marketing, Govt. Of NCT of Delhi, a meeting of Jan-Sunwai was held on 25/08/2015 in the office complex in APMC Azadpur which was chaired by the Secretary, APMC (MNI). Market functionaries in large were present during the Jan-Sunwai and following issues were raised:-

1. Meeting of Jan-Sunwai was started showing the photographs on the screen regarding the poor sanitation condition of Azadpur Mandi, for which commissions agents as well as APMC authorities are responsible for this dirty condition of the mandi.
2. Secretary (MNI), requested to all stackholder to keep Azadpur Mandi neat and clean by checking all who are spreading garbage in mandi.
3. Large number of Palleders were present in the meeting. Sh. Sanjay Kumar, who is a registered Palleder in the APMC Azadpur, raised several issues pertaining to palledars as under :-
 - (i) Wages of Palleder has not been revised since long (33 years).
 - (ii) They do not have any type of I-card issued by APMC Azadpur.
 - (iii) Palledars are not being registered and not issued certificated in this regard.
 - (iv) Palledars are not behaved well by the Commission Agents.
4. Deputy Secretary (Licence) informed that Palledars are being registered and issued G category of Licence, provided they apply for it and at present two palleder have been issued G-category licence.
5. Deputy Secretary (Licence) also informed that I-Card to all labourers can be issued by the APMC Azadpur, provided they submit their request after verification from the concerned Association under which labour is working. Police verification is not required now, but it was mandatory earlier.
6. Sh. Deepak, from Shop No A-261 informed that A & B Blocks road are encroached upon by Mashakhors of Garlic Trade.
7. Sh. Yogesh Sonkar from Shop no. D-418 raised several issues as under:-
 - (i) Allotment of space in Matter Shed. Secretary (MNI) informed that a allotment committee has been formed and allotment will be made as per guidelines approved by the Marketing Committee.
 - (ii) Opening of Gate near Tomato shed, which will improve the Jam problem. Secretary (MNI) asked Dy. Secy. (Gate) to examine the proposal in this regard.
 - (iii) Toilet (Sulabh Sochalya) in D- block is in very depleting condition and needs urgent repair.
 - (iv) Urinal Blocks in Azadpur Mandi do not have any Wash Basin and water fittings.

(V) Time of Jan Sunwai should start at 2.00 PM onwards.

(Vi) D-block sewer has not been cleaned for the long time and all the basement of Shops flooded with sewer water.

8. (i) Sh. Umesh Kumar from Shop No. A-266 suggested that APMC members should also be invited in the meeting of Jan-Sunwai.

(ii) He also drew attention that Iron Garter that has been installed by APMC Azadpur in front of all big Shops in all the four Blocks. At present the conditions of these garter is in very poor state and now it require an urgent repair. EE (Civil) informed that repairing work will start functioning soon as the work for repair has already been awarded.


(iii) Iron Garter in front of Kissan Bhawan has been installed in last 24 hour, as it will create problems in the movement of traffic.

(iv) A & B block drain has not been cleaned since long due to which basements are flooded with sewer water.

(v) Sh. Umesh Kumar also requested for more space for Potato Trade be provided as they do not have space as per their arrival.

9. Sh. Anand from shop A-260 informed that in shade no. 14, fans in middle row are not installed and requested for installation of electric fan.

Secretary (MNI) thanks to all participants of the Jan Sunwai for raising their problems. He assured to all that action will be taken to re-address their respective problems.
