MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 26.11.2018 at 3:30 PM in the Conference Hall of APMC (MNI) Azadpur which was chaired by observer Sh. Udaiveer Singh, Secretary APMC Najafgarh. The issues raised during Jan-Sunwai are as under: -

1. Sh. Yogesh Sonkar, Green Vegetable commission agent from M/s Raj Kishan & Sons, shop no. D-418 raised the issues as under: -

(i) He requested for allotment of Kheera Trade in Matar Shed.

Action: DS(E&M)

(ii) He requested for allotment of Anar Trade.

DS (E&M) informed that allotment process of Anar trade is under process.

Action : DS(E&M)

(iii) Sewer lines are choked in A & D Block of NSM Azadpur & need immediate remedial action.

EE(C) informed that work is award for change of sewer line and work start earliest.

Action : EE(C)

(iv) He also requested for install the security booth near Transformer at shop no. D -438 to stop encroachment & unauthorized parking.

EE(C) inform the booth is ready and will be install earliest.

Action : EE(C)

(vi) He also informed that in A block near Police Chowki police harsh the traders.

Observer directed him to give his written complaint and matter will be examined.

Action: EE(C)/Security

2. Sh. Rajesh Kr., from Poma informed that Sewer line are choked in A block of NSM Azadpur & need immediate remedial action.

EE(C) informed that work for change of Sewer line is start at earliest.

Action : EE(C)

3. Sh. Bijender Tyagi the representative of firm M/s Davender Bijender & Co. from shop no. D-1310, requested for auction space in Green Vegetable.

Action: DS (E&M)

4. Sh. Jagparvesh, Green Vegetable commission agent from M/s Giriraj Fruit Co., from shop no. D-1295 raised the issue as under:-
- (i) He requested for auction space for organic green vegetable.
Observer directed him to give his written request and matter will be examine thereafter.
Action : DS(E&M)
- (ii) He requested for auction space in Green Vegetable.
Action : DS(E&M)
- (iii) He informed that in Gajar Shed (Sangham Shed) the electricity wire is open from various places and need immediate repair.
Observer directed EE(E) to take the immediate action for repair the same.
Action : EE(E)
5. Sh. Ram Kumar, from Shop No. B-813, Lic No. B-601 informed that he received the Khajoor of lower quality but APMC calculate the rate of premium quality, therefore there is a difference in market fee in APMC & firm record.
Observer directed him to give his written request.
Action : DS(MIS)
6. Representative of the firm M/s Banke Bihar Fruits, Shop no. C-677, Lic no. B-4797 requested for auction space for Tarbooj Commodity.
DS(E&M) inform that allotment process for Sharda & Tarbooj is under process.
Action : DS(E&M)
7. Sh. Rajesh Anand from M/s Inder Swarn Anand & Sons, Shop no. B-824, Lic no. B-3906 informed that ramp of B-Block is broken from the last 1 ½ years but no action is taken till date even after so many written request made by him.
Sh. G.U. Islam informed that work is to be tender.

8. Sh. Ashok from M/s Ganpati Traders, Shop no. A-996, Lic no. B-4784 informed that he applied for cancellation of his licence but no action is taken therefore he requested for cancellation of his licence.
Action : DS(Lic.)
9. Representative of M/s Vardhman Trading Co., Shop no. A-1035, Lic no. B-4402 informed that he applied for phar in Lemon Trade from 2010 onwards but till date no action is taken.
Observer directed him to give his fresh written representation.
Action : DS(E&M)
10. Sh. Sandeep Khandelwal, from M/s Om Shyam Traders, Shop no. A-1137 raised the issues as under:-
- (i) He informed that some of the traders selling the Cemented & Clay coated Potato in shed No. 14 which is harmful for the human life. He also sought the status of his earlier complaint.
SEO informed that on his complaint the letter has been sent to FSSAI to take appropriate action on the time. Observer directed DS(Enf.) to send the sample in DAM lab in the presence of complainant.
Action: DS(Enf.)

(ii) He also informed that at Shed No. 14 some of the traders have allotted the space wrongly & some of the traders given there phar on rent on his complaint action is not taken by the APMC.

Observer directed DS (E&M) to check the matter.

Action: DS(E&M)

11. Sh. Deepak Sapra, from M/s Deepak Kr. Trilok Chand, Shop no. A-261 informed that the floor & iron Angel of Shed no. 16 is broken from several places and need immediate repair.


EE(C) informed that agenda is put up in the next meeting.

12. The representative of M/s N. P. & Co., M/s Parduman Singh & Co, Shahjab & Co., M/s Prem Babar Bharat Babbar,, Raj & Sons, Deepak Kr. Trilok Chand, Mehar Sai Fruits & M/s Vardan & Co. informed that they was allotted $\frac{3}{4}$ phar for Mosambi Trade which is too small to manage day to day activity which is necessary to sell Mosambi as the goods sold after shorting and grading. They also informed that Mosambi are received in loose & the Mosambi is packed in kata which is in cylindrical form, hence it is not possible to stack them vertically. Therefore, they requested to increase the space.

Action : DS(E&M)

At the end, it was assured by Observer in the meeting that steps would be taken to address the grievances and problems of the Mandi stake holders at the earliest.
