Minutes of Jan Sunwai

In pursuance of letter no. F8(05)/2015/DAM/MR/2166-77 dated 23/09/2015 received from Dy. Director (AM), Directorate of Agricultural Marketing, Govt, of NCT of Delhi, a meeting of Jan Sunwai was held on 28/09/2015 at 2.30 P.M. in the office complex in APMC (MNI), Azadpur which was chaired by the Secretary, APMC(MNI). Market functionaries in large number were present during the Jan- Sunwai during that following issues were raised:-

1. Sh. Yogesh Sonkar of Shop No. D-418, appreciated the efforts of APMC for Special Encroachment removal and Sanitation drive being carried out from 15th September 2015 to 14th October 2015. He also requested that commission agents be allowed to use some space in front of their shops as shops are smaller in size in comparison of arrival of commodity to their shops. He also raised the issue of space may be allotted in Peas and Khira sheds as some more commission agents dealing in other commodity may also be accommodated there at the time off season Peas and Khira to maximum and better utilization of the vacant space. He also requested for the construction of Gazar shed in D-Block be completed at the earliest.
2. Sh. Vikas Pasricha, Commission Agent of Dabh raised his issue pending in Dispute Sub Committee since long and requested for its solution at the earliest.
3. Mohammed Iliash of Shop No. 41 of Okhla Mandi raised the issues as under:-
 - i) A parallel fruit mandi is functioning out side the Okhla Mandi near Bank, for which some preventive / corrective measures need to be taken he also requested that a letter may also be written by APMC Azadpur to stop the functioning of this illegal Mandi to DDA, MCD or any other appropriate authority.
 - ii) The shortage of staff in Okhla Mandi be filled up.
 - iii) Sufficient number of Security Guards be provided in the Mandi to check the entry of Rickshaw/Rehri etc.
 - iv) Vacant space and plots where ever available in Okhla Mandi be allotted to the traders to accommodate their extra commodity which is essential in the interest of Commission agents.
4. Abdul Rehman Commission agent of Tomato of Okhla Mandi requested for providing additional space so that the arrival of commodity to unload the arrival of commodity in front of their shops.
5. Sh. Raju kohli, Commission Agent of APMC Azadpur gave several suggestions:-
 - i) Solar Panel be fixed on the roof of all sheds of the Mandi, as it will not only generate extra electricity but also reduce the expenditure being incurred on electricity by APMC.

- ii) The space of Peas be allotted to some other commodities when the season of Peas is over avoiding misuse of the space by some vested interest people.
 - iii) New Bank be allowed to function at Kishan Bhawan in New Fruit Market Azadpur
 - iv) Garbage be collected from the Dustbin installed in Adrak Shed of NFM Azad Pur.
6. Sh. Umesh Kumar, Potato Trader from Shop No A-266, raised several issues as under:-
- i) Rain harvesting system be installed in NFM Azadpur, as it will re-charge the ground water level and stop wastage of water.
 - ii) New toilets be constructed on the roof of Dhalows.
 - iii) Wash basin with water taps & Urine Pots where ever required be installed in NFM & NSM Azadpur.
 - iv) Two food huts of 10x10 feets size be provided in each of 21 Sheds in NSM/NFM so that the stack holders may get good hygienic food there.
 - v) To meet the demand of parking space in NFM, an underground parking be constructed in Shed, no. 19 (Temporary Shed) alongside entry road to Gate No. 05.
 - vi) Defogging be made on regular basis in APMC Azadpur & Okhla Mandi to prevent Dengue
7. Sh. Littee, Commission Agent of Mosambi trade, requested to stream line the vehicle of Dabh which start down loading/unloading in front of the Mosambi phars, which cause problems to the commission agents of Mosambi trade.
8. Some Lemon traders requested to allot them space at one place so that they all can functions from single space to gather.
9. Sh. Varun Sharma raised the issue of revision of Wages to Palledar which has not been revised since long. Sh. Rajender Sharma, Member Marketing Committee participating in the discussion informed to him that different association of various trades informed to the Market Committee about the revision of wages to Palledars from time to time. He further informed to Sh. Varun Sharma to submit the request for revision of wages to Palledars to respective associations so that the said associations on further revision of wages may informed to the Secretary, MNI for further action in this regard.
10. Sh. Guru Charan, Tempo Union leader requested that the H category licence for Tempo/LMV which used to issue earlier on charging on Rs. 50 for entry of their vehicles as the present charging on per trip basis is costing to them very higher side. He further informed that their vehicles operating from market yards comes in the category of LMV



not as HMV under which category the gate passes issues by the gate staff which should be stopped immediately

11. Sh. Avadh Narain, Labour union leader requested that all Sulabh Sochalyas should function during the night time also as maximum number of people and truck drivers arrived in the Mandi in the night hours. He also pointed out towards the higher charges being charged by people in Sulabh Sochalyas with the request to make them in order.

Sh. S. K. Jain Spl. Commissioner, present during Jan Sunwai as observer assured all present that all their grievances shall be addressed at the earliest. He also informed that their suggestions in the larger interest of Mandi shall also be implemented as early as possible.

Jan Sunwai meeting ended with vote of thanks to all the market functionaries.
