Minutes of Jan-Sunwai

In pursuance of Circular No. APMC/CO-ORD/Jan.Sun/2015/1739 dated 21.09.2016 a meeting of Jan-Sunwai chaired by Secretary MNI, was held on 29.09.2016 at 03:00 PM at Conference hall of APMC Azadpur. Market functionaries were present during Jan-Sunwai.

While starting the Jan-Sunwai, Secretary (MNI) welcomed all the participants.

1. Sh. Sanaullah Khan Commission Agent, of shop no. B-229 J&K informed that he did not receive any commodity for April-July 2016, However, a message has been received from ADC branch that he did not deposit the market fee, and his arrival's entry has been be stopped. Secy.(MNI) asked the concerned Commission Agent to meet the concerned D.S to re-address his the problem.
 2. Sh. P.S. Gill Commission Agent shop No.-D-1276 highlighted the issue of difference of market fee as per APMC & as per Commission Agent. APMC determines market fee on the basis of Modal rates & Commission Agent/ deposits/ determines on the base of actual rates.
- Secy.(MNI) asked to the MIS Branch, while taking rates of the day they should also contact to different traders association also.

3. Sh. Maheshwar Palledar, informed that sometimes Commission Agent himself or some time his employee misbehave with the labour working under them.
- Secy.(MNI) asked them to contact local police or dial 100 number.
4. Sh. Sanjay Palledar requested that efforts be made to increase the minimum wages of the labour in mandi.
- Secy.(MNI) asked D.S(licence) to conduct a meeting with association of different trades/ Commission Agent & labour.
5. (i) Yogesh Sonkar Commission requested that encroachment on NSM entry gates, on Bhrola village side should be removed. In front of Assistance Security officer's office, encroachment has been made & no action has been taken by the Area ASO.
- (ii) Empty vehicles are parked inside NFM & NSM, no action is taken by the security guards to remove them.
- D.S.(Security) informed that team has been formed for the removal of empty vehicles in Mandi. This team is headed by Sh. A. S. Mann (AS-I).
- (iii) Allotment of seasonal green vegetables be made on priority basis because it is already delayed by more than one year.
- (iv) Traders of pumpkin are selling it in D-Block shed unauthorisedly it should be stopped. **(DS (Enf.) to remove it.)**
6. Sh. Umesh Kumar, Commission Agent of Potato trade made following submissions:-
- (i) Repair on A-B road is not being done despite the fact that condition of road is very poor.
- (ii) In A&D Block, sewers are completely choked & no step is being taken either to clear them or install new sewer line.
- (iii) On Out/ Exit gate lighting system is very poor. No high mast light is functioning on exit road of NSM.
7. Sh. Dinesh Kumar, Commission Agent shop No. A-333 informed that the from 1:00PM to 3:00PM on exit road, there is always a jam. Sh. Ram Niwas, ASO does not take any action to clear the jam.

8. Sh. Akeel Ahmad, Commission Agent informed that sometime, growers do not agree to sell his product as the market rates are not as per his expectation in Mandi & take the stock to another mandi, but Commission Agent has to pay market fee, as the gate pass has been issue in his firm name. It was requested that market fee be waived for the same.
9. Secy.(MNI) suggested that a meeting be undertook between Commission Agent & APMC so sort out the issue of modal rates in the mandi. D.S.CRMIS)
