MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 23/09/2019 at 3:00 PM in the Conference Hall of APMC (MNI) Azadpur in the presence of different stake holders & officers of APMC(MNI) Azadpur. The issues raised during Jan-Sunwai are as under: -

1. Sh. Sandeep Khandelwal, potato traders from M/s Om Shyam Trader, shop no. A-1137 raised the issues as under: -

(i). He requested for removal of unauthorised parking near gate no. 5 & out gate of Azadpur Mandi.

Action: DS (Enf.)/DS(Security)

(ii). He informed that some of the traders selling the Cemented & Clay coated Potato in shed No. 14 which is harmful for the human life. He also stated that no action is taken by APMC in his earlier complaint.

Action DS(Enf.)

(iii). He raised the issue of traffic jam at A, B, C road due to encroachment by the Adda Wala & unauthorized hawkers selling the good on the vehicle which is also Don't even get gate passes.

Action: DS(Enf.)/DS(Security)

(iv). He also informed that during the no entry time if the empty vehicle gone out of the mandi, the traffic police official challan the vehicle because of that there is a unneccesary traffic jam in the mandi. He requested to prevent them from doing so.

Action: DS(Security)

(v). He was informed that some of the shop owner of B & C block constructed the cold storage in the basement of the shop which is illegal.

Action: DS(Enf.)/DS(E&M)

2. Sh. Umesh Updhyay, from M/s Jai Durga Mata fruit, shop no. D-1267 requested for deployment of Assessing Authority after the retirement of the Assessing Officer of D-block.

Action: DS(ADC)

3. Sh. Yogesh Sonkar, of M/s Raj Kishan & Sons, Shop no. D-418 raised the issues as under: -

(i) He requested for installation of Electric lights polls adjacent to the wall of Bharolla from D-403 to D-438.

Action: EE(E)

(ii) He raised the issue of insanitary condition in D-block from Shop No. D-403 to D-436 & he also requested that Sanitation Contractor may be asked to present in the next Jan Sunwai meeting.

Action: DS(Sanitation)

(iii) He requested that the time of the Jan Sunwai may be done at 12:00 Noon for more participation.

Action: DS (Coord.)

(iv) He requested that Azadpur mandi may be closed completely for all the trades on Sunday.

Action: DS(E&M)

4. Sh. Virender Rana, from M/s Om Parkash Badri Nath & Co., Shop No. D-343, requested for more space to the Potao traders due to less arrival of Apple.

Action: DS(E&M)

5. Sh. Dhirender Sonkar, Shop no. D-418 informed that on his RTI application timely & complete reply is not given by the licence branch. He also informed that in his phar at shop a Tea Stall is working which is illegal.

Action: DS(Lic.)/DS(Enf.)

At the end, it was assured in the meeting that steps would be taken to address the grievances and problems of the Mandi stake holders at the earliest.
