MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 26/02/2019 at 3:00 PM in the Conference Hall of APMC (MNI) Azadpur which was chaired by observer Sh. Udaiveer Singh, Secretary, APMC, Najafgarh. The issues raised during Jan-Sunwai are as under: -

1. Sh. Umesh Kr, Potato Commission agent from Shop No. A-266 raised the following points:-
 - (i) He informed that cover shed of "A" block allotted to the 12 commission agent of garlic traders in the year 2000. Presently, few of them subletting their phars. He requested for revised the allotment.
Action: DS (E&M)
 - (ii) He informed that 3rd phase of the Onion shed is not completed even after long time. AE(C) informs that notice and show Cause Notice was issued to the contractor.
Action: EE(C)
 - (iii) He informed that Tin shed of the roof of shed no 7 & 8 is rusted. He requested for repairing & paints the roof of the shed.
Observer asked to AE(C) to see the possibility for repair & paint the roof.
Action: EE (C)
2. Sh. Amit Bansal from M/s Radhey Garlic, shop no. A-281 raised the issues as under:-
 - (i) He requested for Action Taken Report of the Jan Sunwai.
Action: DS (Corrd.)
 - (ii) He informed that work for change the sewer line is not started in A & D block even after auspicious beginning.
Action: EE(C)
 - (iii) He informed that the Iron Angel in front of "A" shops is broken and need immediate repair.
AE(C) informed that Tender to award the work is under process.
Action: EE(C)
 - (iv) He informed that the High Mask Light of A, B, C & D block is not working properly. Some of the Bulb is fuse since long.
Action: EE (E)
3. The representative of M/s. ONP & Co. A-1019, M/s Mehar Sai Fruits. C-549, M/s Deepak Kr. Trilok Chand. A-261, M/s Kashmiri Lal Surinder Kr. A-261, M/s Shehzad & Sons. C-559, M/s Bajrang Traders. A-1138, M/s Sagar Trading Co. D-1232 informed that they was allotted ¼ phar for Mosambi Trade which is too small to manage day to day activity which is necessary to sell Mosambi as the goods sold after shorting & grading. Therefore, they requested to increase the space from 3/4 phar to One phar.
Sh. Rajiv Duhan, AS-I, informed that the Agenda in this regard is placed before the Marketing Committee for decision.

4. Sh. Deepak Sapra, from M/s Deepak Kr. Trilok Chand, Shop no. A-261 raised the issues as under: -

(i) The floor & iron Angel of Shed no. 16 is broken from several places and need immediate repair.

Sh. G. U. Islam, AE(C) informed that Tender to award the work is under process.

Action: EE(C)

(ii) He requested for repairing & paint the roof of shed no 15.

Observer asked to AE(C) to see the possibility for repair & paint the roof.

Action: EE(C)

5. Sh. Pawan Kumar, from Sagar Trading Co., Shop no. D-1232 raised the issues as under:-

(i) He informed that construction of 3rd phase of the shed no 20 (POMA shed) is not started even after long time. He requested that onion traders may be allowed to use the space for loading and unloading the goods till the construction is not started.

Observer asked him to give the written request in this regard.

Action: DS (E&M)

(ii) He informed that in A & D block some of the hawkers selling the goods on the road & create traffic problem. He also informed that some of them were also stolen the goods from the trucks.

Action: DS(S)/DS (Enf.)

6. Sh. Sandeep Khandelwal, from M/s Om Shyam Traders, Shop no. A-1137 raised the issues as under:-

(i). He informed that there is a traffic Jam at shed no. 13 towards park due to encroachment of road by the Hawker & Hotel.

Action: DS (Security)/DS (Enf.)

(ii). He informed that shed no. 14 allotted to the Potao traders but some of the trader selling the onion on the phar.

Action: DS (Enf.)

At the end, it was assured in the meeting that steps would be taken to address the grievances and problems of the Mandi stake holders at the earliest.
