Notice for open spot auction of condemned goods / items

A Public Auction of condemned of goods / items belonging to the APMC (MNI) Azadpur shall be held on 25-10-2018 at 03:00 PM at APMC dormitory in NFM Azadpur. The details of the condemned goods / items and terms & conditions of public auction are as under:-

1. The acceptance of open bid auction of above mentioned condemned items will be based on "As Is Where Is Basis". The condemned items are lying at following address:
APMC Dormitory near Shed No. 6 at New Fruit Mandi, Azadpur.
2. The condemned items can be inspected on any working day between 11 AM to 4 PM. In case of any clarification, the prospective bidder can contact, Dy. Secy. (CT) in office of APMC (MNI) Azadpur.
3. Before participating in the open bid auction, the open bidder will have to deposit Earnest Money of Rs. 5,000/- through Demand Draft / pay order of schedule Banks in favour of APMC.
4. In case of any holiday falls on 25-10-2018, the bid will be extended to the next working day at the same time.
5. The bids received by DAK/FAX/email or by any other means, shall not be entertained.
6. The condemned items will be sold to the highest bidder only.
7. No conditional offer shall be accepted.
8. The highest bidder will have to submit proof of his/her identity (Copy of Aadhar Card/Voter or any other authentic proof) on the day of auction.

9. Highest bidder will have to deposit 50 % of the bid amount offered by him/them at the time of open bid auction through cheque in favour of APMC (MNI) Azadpur.
10. The successful bidder will have to deposit the Entire Bid Amount through Demand Draft of schedule banks in favour of APMC (MNI) Azadpur.
11. The successful bidder will have to remove the items at his own cost within 05 days after depositing the entire bid amount.
12. The cheque of 50% amount received against bid taken on the day of auction and Demand Draft of EMD of Rs. 5,000/- shall be returned to the successful bidder, after receipt that he /she /they will use these items as Scrap.
13. The Earnest Money of Rs. 5,000/- will be returned on the same day to the unsuccessful bidders after closing the open spot auction.
14. Other terms & conditions shall be declared at the time open spot auction.
15. The Secretary, APMC (MNI) reserves the right to accept or reject the highest bid without assigning any reason.
