(3) The period of contract shall be for a period of one year which can be further extended for one year subject to services being provided satisfactory in public interest on the same terms and conditions.

(4) The APMC shall deduct Income taxes and any other applicable taxes on the value of work done from each bill of the contractor as per prevailing government orders. In lieu of above, the APMC shall issue a TDS certificate to the contractor, in relevant from.

for qualifying technical bids:-

TERM AND CONDITIONS

1. Cranes should be in good running condition and as per the conditions/ guidelines framed by transport department, GNCT of Delhi and within the purview of restrictions laid down by the Hon'ble Supreme Court of India.
2. The cranes should be well equipped with hydraulic system with mounts and padded body capable to lift all type of cars / tempos / champions and other light and medium size vehicles.
3. The crane will be at the disposal of the Security wing of APMC (MNI), Azadpur.
4. The crane will be parked in front of NSM & NFM main gate.
5. The crane will be used for smooth and effective regulation of traffic in Azadpur fruit & vegetable Market, Kela Siding & Transport centre for removing the wrongly parked vehicle and encroachers, and any other purpose for better regulation of smooth flow of traffic. The contractor will also maintain log book for each crane and entry of daily work done by the crane be got duly verified/ certified from the Assistant Security Officer (ASO)/ Security Supervisor (SS) concerned. Copy of log book shall be enclosed with the monthly bill.
6. This office shall not be responsible for any breakage, damage or any other problem which may occur in the crane while functioning for the work assigned. The owner of the crane shall get the crane repaired/ serviced himself, and during the period of repair the contractor has to provide the other crane as replacement.
7. The crane along with drivers and requisite personals should be made available without any break on all days. The drivers should possess valid driving licence for driving Heavy Vehicles issued by Transport Department of Delhi.
8. Any equipment required with the crane for the job are also to be supplied by the owner of the crane.
9. The agency will be liable to pay the penalty of Rs.1000/- per day for any lapse/ failure in discharging duties. The particulars of the driver with photograph, who will be driving the crane, shall be provided in the office of Deputy Secretary (Security). No other person except the authorized driver will be allowed to drive the crane.
10. The certificate of utilization has to be obtained by the owner of the crane from Assistant Security Officer (ASO) or any authorized officer of this office on daily basis.
11. The hiring charges of cranes will be made on monthly basis, after deduction of prescribed TDS.
12. The cranes shall remain in the market from 08:00AM to 05:00PM all days including Sunday.

- 13.A Security deposit @ 10 % of tendered amount shall be deposited by the Agency before award of contract with the APMC, Azadpur. The security amount will be released after 3 month of termination/ expiry of contract.
- 14.The Agency shall have to arrange Heavy crane in case of emergency for removal of big truck at its own cost and no extra charges shall be paid in such cases by APMC, Azadpur.
- 15.In case the vehicle get damaged during the course of removal of vehicle, the agency shall be fully responsible for damage charge to be paid to the owner of the vehicle.
- 16.The APMC holds the right to terminate the contract any time during the contract period without assigning any reason there-of after giving one month's notice.
- 17.The APMC (MNI), Azadpur does not bind itself to accept the lowest or any other tender, and reserves to itself the authority to reject any or all of the tenders received without assigning any reason.
- 18.In case of any dispute arising between the parties the matter may be referred to an Arbitrator. The first party shall appoint the Arbitrator (without consulting the second party), and the decision of Arbitrator shall be final and binding on both the parties.
