Minutes of Jan-Sunwai

Jan-Sunwai was held at 3:30 PM on 18.12.2017 in the conference hall of APMC (MNI) Azadpur which was chaired by Secretary (MNI) and Secretary (APMC, Shahdara) was also present as an observer. The issues raised during Jan-sunwai are as under:-

1. Sh. Bhagat Singh prop of M/s Ganesh Bhagat & Co., Shop no. D-414 raised the issues as under: -

(a) He requested that while issuing gate pass, weight of the Anar box be considered as 8 K.g. instead of 10 Kg as mentioned in the Bilty.

Dy. Secy. informed that gate passes are issued on the basis of the Bilties on which the detail of the commodity is mentioned.

Action: DS(Gate)

(b) He also submitted that on the main entry road at Gate No. 1 is encroached by the unauthorized parking of the cars/vehicles of the traders/market stake holders due to this there is always jam situation on the entry gate no. 1.

Secretary (MNI) informed that matter will be examined and action will be taken to address the grievances.

Action: DS(Security)

(c) He also highlighted the issue of shortage of drinking water facility in the Piao constructed by the APMC in New Subji Mandi Azadpur.

EE(C) informed that although there are nos. of Piao available in the new subji mandi Azadpur in which drinking water facility is available, yet APMC will examine the non-availability of water in the existing Piao if any.

Action: EE(Civil)

2. Sh. Deepak commission agent of shop no. D-1388 highlights the traffic jam in the D-block Subji Mandi Azadpur.

Action: DS(Security)

3. Sh. Umesh Kumar, potato Commission Agent of shop no. A-266 raised the issues as under:-

(a) He asked about the Date of next meeting of the newly constituted market committee of Azadpur as the lots of agenda are relating to licence are pending.

Secretary (MNI) informed that meeting of the marketing committee will be held very shortly & file is under process to fix the date of the meeting.

(b) He proposed that the column of nominee in licence be made available at the time of grant of licence.

Secretary (MNI) informed that the matter will be examined by the concerned branch.

Action: DS(Lic.)

(c) Facility of Sulabh Sochalaya be made free of cost in the APMC Azadpur as it has been done in the DUSIB department.

Action: EE(Civil)

(d) He proposed that the multilevel parking be made in shed no. 18 in NFM Azadpur.

EE (Civil) informed that to readdress the problem of parking, traffic Jam etc. consultant is being hired at DAMB level, who will suggest measures to ease the problems in Mandi

Action: EE(Civil)

It was assured in the meeting that steps would be taken to address the graveness and problems of the mandi stake holders & meeting was ended with thanks to the chair.
