MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 22.10.2018 at 3:00 PM in the Conference Hall of APMC (MNI) Azadpur which was chaired by Secretary, APMC (MNI) Azadpur & Smt. Amita Suman, Dy. Director (A.M.) were also present. The issues raised during Jan-Sunwai are as under: -

1. Sh. Pawan Kumar, of M/s Sagar Trading Co., Shop No. D-1232, Lic no. B-4082 raised the issues as under: -

(i) He informed that he was allotted $\frac{3}{4}$ phar for Mosambi Trade which is too small to manage day to day activity which is necessary to sell Mosambi as the goods sold after shorting and grading. He also informed that Mosambi are received in loose & the Mosambi is packed in kata which is in cylindrical form, hence it is not possible to stack them vertically. Therefore, he requested to increase the space.

Action: DS(E&M)

(ii) He also informed that in the Onion trade the space of 9ft allotted to the Onion traders is too small because from Diwali to January there is a huge arrival comes in the mandi from Kaithal (Alwar). He requested for alternate arrangement in addition to existing space.

Secretary (MNI) asked Sh. G.U. Islam, AE(C) & DS (E&M) to check the possibility for additional alternate arrangement for onion traders during the peak season.

Action: DS(E&M)/AE(C)

(iii) He also raised the issue of encroachment in front of Onion Phar.

Secretary(MNI) directed EE (Civil/Security) & DS (Enforcement) for special drive to remove the encroacher/ encroachment.

Action: Security^{Br.}/ Enf. Br.

2. Sh. Sandeep Khandelwal, from M/s Om Shyam Traders, Shop no. A-1137 raised the issues as under: -

(i) He informed that some of the traders selling the Cemented & Clay coated Potato in shed No. 14 which is harmful for the human life. He also sought the status of his earlier complaint.

Secretary(MNI) informed that on his complaint the letter has been sent to FSSAI to take appropriate action on the time.

Action: DS(Enf.)

(ii) He also informed that at Shed No. 14 & 16 some of the trader have allotted the space wrongly and on his complaint action is not taken by the APMC.
Secretary (MNI) directed DS (E&M) to check the matter.

Action: DS(E&M)

3. Sh. Deepak Sapra, from M/s Deepak Kr. Trilok Chand, Shop no. A-261 raised the issues as under: -

(i) The floor & iron Angel of Shed no. 16 is broken from several places and need immediate repair.

Secretary(MNI) asked Sh. G.U. Islam, A.E. (C) to visit the Shed no. 16 and submit the report immediately.

Action: E.E.(Civil)

(ii) He requested to replace the old Electricity wiring in shed no. 16 as the existing line is very old.

Action: EE(E)

(iii) He also requested for charging point for electric weighing machine in the Phar of shed No. 15 & 16.

Secretary (MNI) asked EE(E) to take the necessary action immediately.

Action: EE(E)

(iv) He also requested for online facility for renewal of Licence & apply for new licence.


Secretary(MNI) asked DS(Lic) for check the probability on his request.

Action: DS(Lic)

4. The representative of M/s N. P. & Co., M/s Parduman Singh & Co, Shahjab & Co., Bharat Chand & Co., & M/s Vardan & Co. shows there unhappiness from allotment of Mosambi trades as they have been allotted the ¼ auction phar which is too small for shorting the mosambi Grade wise and for auction.

Action : DS(E&M)

At the end, it was assured by Secretary(MNI) in the meeting that steps would be taken to address the grievances and problems of the Mandi stake holders at the earliest.
