MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 23.04.2018 at 11:00 AM in the Conference Hall of APMC (MNI) Azadpur which was chaired by Secretary (MNI) and Sh. A. Nedunchezhiyan, Secretary(DAMB) was also present as an observer. The issues raised during Jan-Sunwai are as under: -

Trader from Leechi Merchant Association requested that Leechi commodity is highly perishable fruits & it should be allowed to be sold on Sunday without time restriction. Secretary (MNI) informed that the Marketing Committee decided that on Sunday the sale of the commodity will be allowed only upto 10:00AM.

2. Sh. Manoi Harjani from Mosambi Traders requested for earliest allotment in Mosambi Traders. It was informed by Secy.(MNI) that process of allotment of Mosambi Commodity is under process.

 - There is Traffic Jam on night at shed No. 9&10 in NFM Azadpur.

- Sewer lines are chowked in A & D Block of NSM Azadpur & need immediate remedial (ii) action.
 - Secretary (MNI) informed that tender for awarding the work of New sewer system in A & D Block is under process.
