MINUTES OF JANSUNWAI

Following issues were raised during the Jansunwai.

1. Sh. Dhanesh, Grower from Kisaan Shed/I. Card Holder stated that he is satisfied about the development work of APMC Market Yard.

2. Sh. Subhash Chug, Proprietor of M/s Subhash Vegetable Co, Shop No. D-403, has informed that high mast lights near Shop No. D-403 is not working for last 4 months and requested to resolve the problem.

EE(E) informed that the tender for new LED high mast lights has already been floated and it is in awarding stage, problem will be resolved shortly.

3. Sh. Amit Sood stated that a telephone booth in front of Shed. No. 13, NFM, Azadpur was locked by the APMC Office on the complaint made by him. Now he has requested to allow him for running above said booth.

DS(E&M) asked that a written request may be given in the office thereafter his matter will be examined and action will also be taken as per rule.

4. Sh. Rajesh Gupta from A-Block raised the issues are as under: -

- (d) He also reported that some traders have been deposited their market fee in wrong head (Market Fee Arrear), earlier such traders have requested to change/correct the market fee head. But no action are being taken by this office.

- (a) Sewer Lid at C & B road are damaged due to which traffic movement are being suffer.

Action:EE(C)


- (b) Garbage may be lifted from Dhallow timely.
