MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 24/06/2019 at 3:30 PM in the Conference Hall of APMC (MNI) Azadpur in the presence of different stake holders & officers of APMC(MNI) Azadpur. The issues raised during Jan-Sunwai are as under: -

1. Sh. Dharmvir from M/s Vikas Kr Manish Kr, shop No. A-321 raised the issues as under: -

(i). He informed that he was allotted $\frac{1}{2}$ phar in potato trade, but from few days he was allowed to work only $\frac{1}{3}$ phar and the space is too small to work. Therefore, he requested to allow him to work from $\frac{1}{2}$ phar.

Action : DS(E&M)

(ii). He also requested for re-allotment of phar in potato trade.

Action: DS(E&M)

2. Sh. Manish Sonkar, from M/s Rajender Kr. & Sons, Shop no. D-1201 informed that he was allotted phar no. 1 in Kheera trade from many years. Now he came to know that APMC is under process for re-allotment of Kheera phar. Therefore, he requested that re-allotment process may not be carried out and he may be allowed to work continue at phar no.1.

Action: DS(E&M)

3. The representative of the firm M/s Guru Kirpa Lemon house, shop no. A-245 informed that he was allotted the phar in lemon trade. But due to cancer of one the partner firm could not have done any business from some of the year and the phar allotted to him was cancelled by the APMC. Now he was again continuing his business and requested for auction space in lemon trade.

Action: DS(E&M)

4. Sh. Rajesh prop of M/s Rajesh & Co., shop no. D-397 requested for fresh survey in Sangam shed allotted to Green Vegetable traders. He also informed that some traders have given their phar on rent.


Action: DS(E&M)

5. Sh. Yogesh Sonkar, of M/s Raj Kishan & Sons, Shop no. D-418 raised the issues as under: -

- (i) He requested for installation of Fan & Light in Kheera Shed. Action: EE(E)
- (ii) He requested that rent of the Sangam shed may be taken from the licensee not from the Association. Action: Ds(E&M)
- (iii) He requested for shifting of Delhi fire brigade water tank from kheera shed. Action: EE(C)
- (iv) He requested to allow 10 phar of Matar shed to the Kheera traders due to large arrival of Kheera. Action: DS(E&M)
- (v) He raised the issue of illegally selling of paneer in the NSM Mandi. Action: EE (E)
- (vi) He requested for installation of Electric lights adjacent to the wall of Bharolla from D-403 to D-438. Action: EE(E)
- (vii) He also requested for the arrangement of water & tea in the Jan-Sunwai meeting. Action: DS(CT)

6. Sh. Mahender Sharma, from M/s Mahender Sharma & Co., shop no. D-1204 requested for auction space in green vegetable. Action: DS (E&M)

At the end, it was assured in the meeting that steps would be taken to address the grievances and problems of the Mandi stake holders at the earliest.
