MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 24.09.2018 at 3:00 PM in the Conference Hall of APMC (MNI) Azadpur which was chaired by Secretary, APMC (MNI) Azadpur. The issues raised during Jan-Sunwai are as under: -

1. Sh. Sumit Chaudhary, from M/s Sunder Dass Dhanraj & M/s Sunder Dass & Sons, Shop no. B-184 informed that due to same Markka of the firm gate passes of his firm issued wrongly by the Gate staff in the wrong firm.

Secretary (MNI) directed him to mention the Licence number on the bilty of the firm. Secretary(MNI) also directed to DS(Gate) that without Licence number on the bilty no gate pass should be issued & in this regard traders & association may also be informed through SMS & Circular by the Gate Branch.

Action: DS(Gate)

2. Sh. Akeel Ahmed of Shop No. A-341 raised the issues as under: -

- (i) He informed that SMS of gate pass issued was received late, it received even after 3 to 4 days by the gate staff.

Smt. Veena Chopra, IT representative informed that some time gate staff do not synchronize the data timely & not open the SMS window. Secretary(MNI) asked DS(Gate) to direct all gate staff for master synchronize the data after every 15 minutes positively and not to close the SMS window failing which action will be taken against the faulting staff.

Action : DS(Gate)/DS(IT)

- (ii) Requested for auction space for green vegetable in the Sangam shed.

Action : DS(E&M)

- (iii) He informed that wall attached with the Bharola Village is broken.

Action : EE(Civil)

- (iv) He informed that near Transformer & toilet block at A&B chowk in NSM Azadpur there is traffic Jam due to encroachment.

Secretary(MNI) asked the DS(Security)/ Enforcement to remove the encroachers and letter in this regard may also be sent to Chowki incharge.

Action : DS(Security)

3. Sh. Sandeep Khandelwal, from M/s Om Shyam Traders, Shop no. A-1137 raised the issues as under:-

- (i) He informed that some of the traders selling the Cemented & Clay coated Potato in shed No. 14 which is harmful for the human life. He also sought the status of his earlier complaint regarding allotment of space in shed No.16 to Potato Traders.

Secretary(MNI) asked to complainant to provide the list in writing of the traders who are selling Cemented & Clay coated Potato & also directed to DS(Enf.) to check the status of the complaint & action will be taken accordingly.

Action: DS(Enf.)

- (ii) He also informed that at Shed No. 14 & 16 some of the trader have allotted the space wrongly and on his complaint action is not taken by the APMC.

Secretary (MNI) directed to DS(Vig.) to inquire the matter.

Action: DS(Vig.)

- (iii). He informed that there is a traffic Jam near shed no. 16 due to encroachment of road by the private Vehicle.

Secretary (MNI) directed to DS(Security) to ban the parking of private vehicle in the NFM Area.

Action : DS(Security)

4. Sh. Bijender Tyagi the representative of firm M/s Davender Bijender & Co. from shop no. D-1310, requested for auction space in Green Vegetable. He also requested that APMC should allot the auction space for green vegetable on priority basis.

Action: DS (E&M)



Action : DS(E&M)

6. Sh. Sanjay, Palledar informed that nug labour rates of different commodities in Mandi has not been revised since long.

Action: DS (Labour welfare)
