## MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 25.06.2018 at 03:00 PM in the Conference Hall of APMC (MNI) Azadpur which was chaired by the Secretary, APMC (MNI) Azadpur & Sh. Udaiveer Singh, Dy. Secretary (DAMB) was also present as an observer. The issues raised during Jan-Sunwai are as under: -

1. Sh. Yogesh Sonker, Shop no. D-418, vegetable commission agent raised the issue as under:-
  - (i) Sewer lines are chowked in A & D Block of NSM Azadpur & need immediate remedial action.  
EE(C) informed that it is expected that process for lying of new sewer line in block A&D will start in October 2018.  
Action: EE(C)
  - (ii) There is darkness on the road starting from the D-403 to D-438 in new Subji Mandi Area.  
AE (E) informs that the installing of new LED on the said area is under process & will start functioning shortly.  
Action: EE(E)
  - (iii) Allotment of Green Vegetable in D block shed & Sangham shed be made on priority basis.  
Secretary (MNI) inform that allotment of Green Vegetable will take time as the present Sangam shed of Green Vegetable is to be dismantled and make a new shed on the location by the Engineering branch of APMC Azadpur.  
Action: DS (E&M)
2. Sh. Devender Kumar, STD Booth operator requested that his electricity load charges be made rational because presently he is getting bill of Rs. 5,000/- per month for the load of 5 KW but in actual he is using load of electricity more than 2KW.  
Secretary (MNI) asked the AE (E) to reassess his electricity load of the Booth. Secretary (MNI) also asked to the AE(E) to get the load survey of whole Mandi including office building and submit his report within 10 days.

3. Sh. Vijender Tyagi, Green Vegetable Trader raised the issue of phar allotment in the Sangam Shed.  
Secretary (MNI) inform that allotment of Green Vegetable will take time as the present Sangam shed of Green Vegetable is to be dismantled and make a new shed on the location by the Engineering branch of APMC Azadpur.
