## MINUTES OF JANSUNWAI

As scheduled meeting of Jansunwai was held on 25/11/2019 at 3:00 PM in the Conference Hall of APMC (MNI) Azadpur in the presence of different stake holders & officers of APMC(MNI) Azadpur. The issues raised during Jan-Sunwai are as under: -

1. Sh. Yogesh Sonkar, of M/s Raj Kishan & Sons, Shop no. D-418 raised the issues as under: -

(i) He requested that traders of "Peas" may also be allotted the space in Shed no. 5 & 6 also during the allotment of Phar due to large no. of traders.

Asst. Secy-I(E&M) informed that allotment of Peas trade is under process.

Action: DS(E&M)

(ii) He raised the issue of insanitary condition in D-block & also requested that the work of change of sewer line may also be start urgently in D block.

Sh. G.U. Islam, A.E. informed that work cannot be start because some trader association not satisfied with the work of the contractor done in "A" block.

Action: EE(C)

(iii) He also informed that Road of the "D" block from shop no. D-403 to D-403 is broken form several places & need immediate repair like Chapis etc.

Sh. G.U. Islam, A.E. informed that award of construction of road is under process.

Action: EE(C)

(iv) He also requested for more space to the members of Ever Green Kheera Union in Kheera shed due to large no. of the members.

AS-I (E&M) informed that the request will be considered as per rule/allotment policy.

Action: DS(E&M)


(v) He also requested that Local Subji traders may not be remove from the Sangham shed till the new space allocation.

2. Sh. Akeel Ahmed, Shop no. A-341, from M/s Akeel Ahmed & Co. raised the issue as under: -

- (ii). He requested for auction space in Peas shed.

- (iii). He requested to eliminate the requirement of auction platform for grant of new licence.

- (iv). He raised the issue of traffic jam in A, B road in NSM Azadpur.

- (v). He also raised the issue of stary animal in the Mandi.  
AS-I (Security) informed that a letter will be issued to M.C.D. to remove animal in the mandi.

3. Sh. Dhirender Sonkar, Shop no. D-418 informed that on his RTI appeal timely reply is not given by the licence branch. He also raised the issue of Banana stalk dirt in front of the shop.  
Action: DS(Lic.)/DS(Enf.)
4. Sh. Rahis Ahmed, Shop no. A-296 from M/s Sahid Sajjad Ali Co. raised the issue as under: -
- (i). He informed that in A Block Road water slopes is towards the platform & sewer line is also chowked.  
Sh. G.U. Islam, AE assured him to check the water level.  
Action: EE(C)
- (ii). He also informed about the illegal vendor sitting in the shed no. 18.  
AS-I (Enf.) informed that enforcement staff removed illegal venders' day by day in the mandi.  
Action: DS(Enf.)/DS(Security)
