Minutes of Jan-Sunwai

Jan-Sunwai was held at 2:30 PM on 28.09.2017 in the conference hall of APMC (MNI) Azadpur which was chaired by Secretary (MNI) and Secretary (DAMB) was as an observer. The issues raised during Jan-sunwai are as under:-

1. Sh. Vikash from Om Fruits Shop No. B-3782 raised the issue of Dispute sub committees & has informed that his case was not resolved for last three years.

Action DS(DSC)

2. Sh. Bhagat Singh (Prop.) of the firm M/s Ganesh Bhagat & Co, Shop No. D-414 raised the following issues: -

- (a) He was charged interest on the delayed payment of market fee & dishonour of cheque.

Official from ADC Branch informed that commission agent was charged interest for the late payment of market fees which is as per law of APMC Act.

- (b) He requested that market fees payment may also be accepted through RTGS/NEFT.

It was informed that APMC has developed a programme through which challan will be generated & commission agent can make payment through cheque/RTGS/NEFT/Draft etc.

3. Sh. Pritam Kumar of the firm M/s Jagan Nath & Company, Shop No. B-235 raised following issues:-

- (a) That sewer in front of his shop are choked and in rainy season it overflows. Moreover, he has requested in the last Jan-sunwai for the replacement of Manhole cover. He further informed that manhole cover been replaced without hole.
- (b) He also requested that a round the clock control room be setup and a telephone number of this control room be circulated among all stake holders in Mandi for all grievances.

Action EE(c)

4. Md. Rashid, Commission agent of the firm M/s Chand Sitra Fruits & Vegetable Co. Lic. No-189 Sub-Yard Okhla made a request for Phar in Fruit or vegetable as per his eligibility in sub-yard Okhla. (If allotted in old flowers market space in Okhla).

5. Yogesh Sonkar of the firm M/s Raj Kishan & Sons, Shop No. D-418, Commission agent raised the following issues:-

(a) The blockage of sewer in entire D-Block of NSM Azadpur. Conditions of Bharola road is also in worse condition, during rainy seasons there is too much mud that a person on foot can not cross Bharola Road.

(b) He also requested that allotment of matter Shed also be made.

Action EE(c)/DS(E&M)

6. Sh.Umesh Kumar potato commission agent raised the following issues as under :-

(a) He informed that in entire shed No. 14 electricity LED bulbs are not in working conditions.


(b) High Mast Light in NFM also not functioning.
